

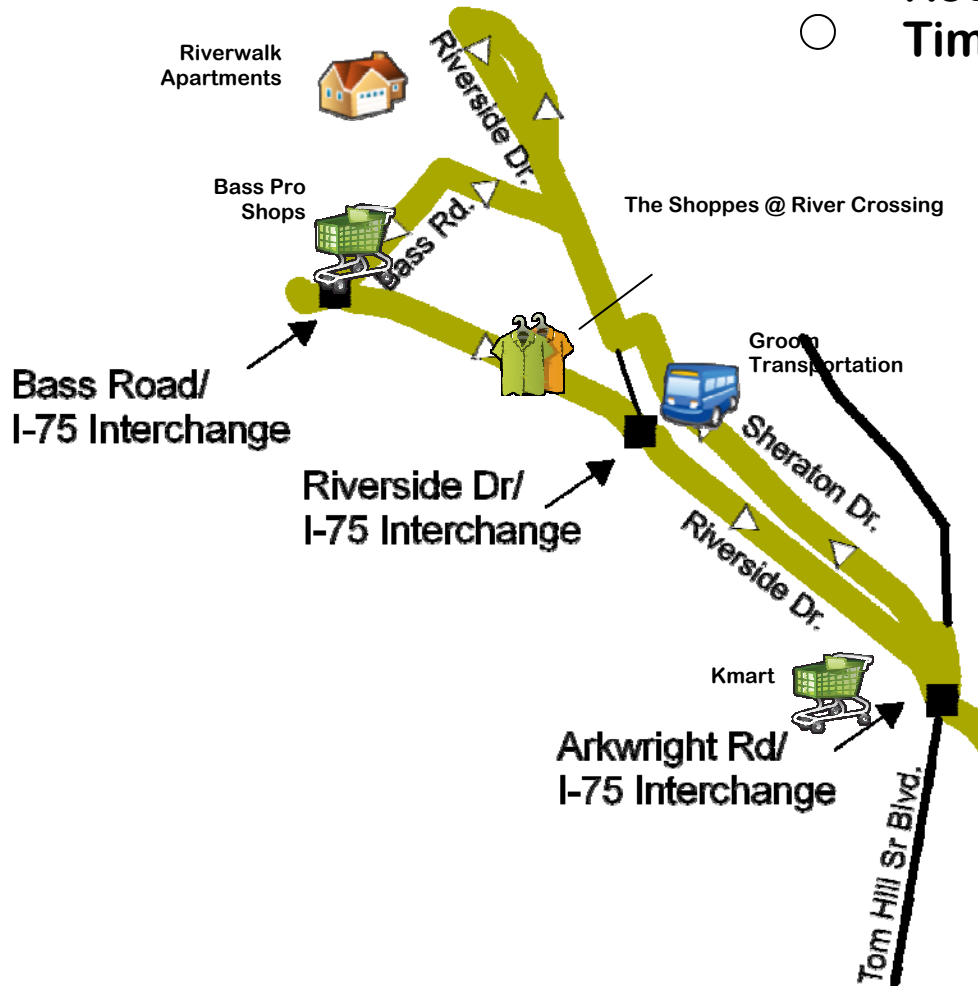


Route 13
